

United Way Worldwide recently launched a national public service advertising campaign, in partnership with the Ad Council and underwritten 100% by the Rockefeller Foundation, to spotlight the many benefits of **211**. 

211 Second Quarter 2021 Results

United Way of Lake County's second quarter (Q2) 2021 report is **now available for download**. The report provides a snapshot of the demographic data and top needs requested from 211 between April 1, 2021 and June 30, 2021. The goal of this report is to share a quarterly overview of 211 data on top community needs and the populations we serve in Lake County.

During this time, 211 received a total of 2,494 calls and texts with 3,320 needs requested. This was a 9% decrease in calls and texts compared to the prior quarter, and a 27% decrease in needs. In addition, 7,605 users visited the 211LakeCounty.org website with 9,219 web sessions.

The top reasons people contacted 211 were:



As compared to the prior quarter, Housing & Shelter and Utilities remain the top two needs, while Mental Health & Addictions has shifted to #3 ahead of Healthcare and Food.

Reports are compiled using anonymous data provided by the 211 Contact Center at Interface Children & Family Services and the 211 Lake County database, as well as website analytics. The reports are intended to assist with proactive community planning and informed decision-making.



Need Help Paying Rent or Utility Bills?

Are you unable to afford your housing costs in Lake County because of the pandemic? If so, you may qualify to get help paying your rent and utility bills.

The Lake County Federal Emergency Rental Assistance Program (FERA) provides rent and utility assistance for eligible households financially impacted by the pandemic. Get Kids Covered

The best way to protect kids is to keep them covered. Illinois' Medicaid and Children's Health Insurance Program (CHIP) offer free or low-cost health coverage that cover doctor's visits, hospital stays, prescriptions, vaccines and more.
