We were thrilled by the number of community members who joined us last week to learn more about 211 and celebrate our third anniversary of services for Lake County.

### **Our 211 Annual Report**

Check out our new 211 Annual Report for FY2022 that highlights the tremendous impact 211 continues to make in our third year of operation, including **57,374** connections to help! This year, we answered 9,498 calls and texts, with 15,057 needs requested. In addition, 39,518 users visited the 211LakeCounty.org website with 47,876 web sessions.

The report is **now available for download** and provides a snapshot of the demographic data and top needs requested of 211 between July 1, 2021 and June 30, 2022. # Lake County Rental Assistance Program Now Open

Lake County renters who faced financial hardship during the pandemic may **apply** for the new Lake County Rental Assistance (LCRA) Program, which provides help for individuals paying rent. The application period runs through November 15, 2022.

Eligible households may receive up to six months of assistance with rent. This can include up to three months' future rent and up to six months of total assistance. Households can receive up to six months of assistance total, including assistance from past programs such as the Lake County Federal Emergency Rental Assistance Program (FERA).

#### **ACA Open Enrollment Starts November 1**

Open enrollment for the Affordable Care Act (ACA) marketplace begins November 1, 2022 and runs through January 15, 2023, for healthcare coverage in 2023. Starting November 1, you can log into **HealthCare.gov**, fill out an application and enroll in a 2023 Marketplace health plan. Enroll by December 15, 2022 for coverage that starts January 1, 2023.

If you are currently enrolled in an ACA plan for 2022, you will be automatically enrolled for 2023. During open enrollment, you can review your plan and make changes. You may have new choices for health coverage, and you must update your application to get the right savings.
