Welcome to the 61st edition of our 211 newsletter, where we share information on 211 services and benefits, funding updates, and opportunities for you to become an advocate for 211.

#### **211 Provider Survey Results**

Twice a year, United Way of Lake County surveys 211 service providers to gather feedback on what they think about our services. Here are some things we learned from the 101 providers who responded to the most recent survey conducted in October:

- **91%** strongly agree/agree that 211 is a trusted resource—an increase from 86% in the prior survey.
- **84%** of agencies that have received referrals from 211 report referrals are always/usually appropriate— the same as 84% in the prior quarter.
- **82%** of agencies that have received referrals from 211 report referrals are always/usually appropriate. This is consistent with 82% reported in the previous survey.
- **79%** of agencies report that 211 has helped their staff's efficiency and effectiveness. This is slightly higher than 77% in the prior survey.
- **79%** of agency staff always/usually knows when to appropriately refer clients to 211. This is a slight increase from 78% in the previous quarter.

Thank you to the providers who responded to the survey! We appreciate your feedback and remain committed to delivering a best-in-class 211 service for our Lake County community members.

# 211 Advisory Council Meeting

The 211 Advisory Council met on November 8 for its quarterly meeting to review 211 program results from the previous quarter, including key metrics by goal, and trend information on 211 contacts and needs presented.

Nelly Guzman shared an agency spotlight on Catholic Charities and provided an overview of several programs,

including the Lake County Emergency Assistance Program which provides homeless prevention services for rental payments, shelter and other types of assistance, and the Family Self-Sufficiency Program which assists single head of household individuals with case management, employment placement and supportive counseling. Kristi Long, Chair of 211 Illinois, shared an update on the 211 state grant. Allen Swilley, the new Executive Director at PADS Lake County, discussed the growing number of individuals they are serving with half being children, how the face of homelessness is shifting to larger families and opportunities to increase housing through fixed shelters. The council also talked about the next steps for 211 marketing, community engagement and resource development.

Welcome to our newest advisory council members: Lake County Board Member J. Kevin Hunter, Mathew Rizzie with the GLCU Foundation for Financial Empowerment, and Allen Swilley with PADS Lake County. We look forward to their involvement. The council will reconvene on February 14.



# **Engaging with the Community**

We were thrilled to connect with more than 600 community members at Family First Center's Health Fair on November 19 at Greenbelt Cultural Center in North Chicago. The event raised awareness of health and wellness resources, and featured health screenings and education on healthy habits. United Way of Lake County's 211 team staffed a resource table and shared 211 materials to help guide people to a wide range of local available resources.
