### **211 Advisory Council Meeting**

The 211 Advisory Council met on February 14 for its quarterly meeting to review 211 program results from the previous quarter, including key metrics by goal and trend information on 211 contacts and needs presented.

Bruce Johnson, CEO of Nicasa Behavioral Health Services, and Tim Sashko, President of the Lake County Board of Health, spotlighted a new public safety and military behavioral health initiative underway. Bethany Williams, Strategy and Intelligence Director with Lake

County Partners, provided an in-depth report on the intersection of Lake County's labor force, employment and housing.

Kristi Long, Chair of 211 Illinois, shared a state 211 update. The council also discussed the next steps on 211 marketing, community engagement and resource development.
