Kane County Launches 211


Did you hear the news? We are excited that another Illinois county recently launched 211 services. Kane County, the fifth-most populated county in Illinois, went live with 211 this past November 1. The service offers residents free and confidential assistance with needs such as emergency shelter, food, utility assistance, counseling, senior services, employment and health care.



With more than 3,000 organizations offering over 14,000 social services, Kane County recognized that it can be overwhelming and confusing for residents to know who does what and exactly where to get help when needed. 211 is a free, centralized, anonymous place to start, with specialists on hand to help sort out the options.

Batavia United Way officials say they first considered the need for 211 after an unverified gun threat at Batavia High School last year resulted in a flood of non-urgent calls to the school and police. As demonstrated in many other communities across the country, 211 is not only available to support everyday challenges, but also can be instrumental during times of crisis and disaster to provide up-to-date information and connect those in need with available services.

As they say, 211 is the number to call when you don't know who to call.

According to United Way Worldwide, 211 is available to 94.2% of the U.S. population with most states having 100% coverage yet Illinois has only 29% coverage. In 2018 alone, 211 made more than 12.6 million connections to help.

While Chicago's 311 service differs from 211 in that it allows residents to request, track and explore non-emergency city services, such as requesting garbage carts and pothole repairs, 311 does assist with some health and human services focused on homelessness prevention.

United Way of Lake County is looking forwarding to joining nearby Kane and McHenry counties to implement 211 services and expand coverage in Illinois. Later this year, Lake County residents will simply be able to call 2-1-1 for personal assistance connecting to a variety of resources such as shelter and housing options, supplemental food programs, financial assistance, mental health and

addiction counseling, and many other critical services. Thanks to the collaboration of so many wonderful partners and individuals, we continue to make good progress in bringing this essential resource to Lake County residents.
