Illinois CPA Society Opens Accounting Scholarship Application Window

Accounting students attending Illinois colleges and universities are invited to apply for scholarships worth up to \$4,000 each.

CHICAGO, Feb. 7, 2023 – In a continued effort to provide valuable resources to accounting students and increase the pipeline of future certified public accountants (CPAs), the Illinois CPA Society and CPA Endowment Fund of Illinois are excited to announce applications are now being accepted for more than 40 scholarships ranging from \$1,000 to \$4,000 each that will be awarded for the 2023-2024 academic year.

These scholarships provide essential financial assistance to qualifying accounting students across the state of Illinois and reward them for their hard work and academic success. Applicants must be junior, senior, or graduate-level accounting students enrolled at Illinois colleges or universities who demonstrate financial need, academic achievement, and leadership qualities. There is just [one application](#) to submit for any or all scholarships for which the student is eligible. The application deadline for the following scholarships is April 1, 2023:

- **Illinois CPA Society Accounting Scholarships** for seniors or graduate students.
- **Herman J. Neal Accounting Scholarships** for Black/African American juniors, seniors, or graduate students.
- **James A. Sikich Visionary Scholarships** for seniors or graduate students.
- **Women's Executive Committee Advancing Women in Accounting Scholarships** for female seniors or graduate students.

Apply NOW for the DCFS 2023 Scholarship Program.

A minimum of 53 scholarships will be awarded, including four to children of veterans. Eligible applicants include youth in care, youth who aged out of care at age 18+ and youth who went to adoption or guardianship from care.

Recipients receive:

- Tuition and academic fee waivers to be used at public Illinois community colleges and universities.
- A monthly grant to offset other expenses.
- A medical card.

SCHOLARSHIP APPLICATION REQUIREMENTS

Eligibility

This scholarship is to recognize academic achievement and to encourage academic advancement of African-American students.

- . Applicant must be a high school senior and a resident of Lake County (IL) area.
(Attending either North Chicago, Waukegan or Zion high schools or other high schools within Lake County (IL) as determined by Harbor Lites (IL) Chapter's Scholarship Committee
- . Applicant must have a 2.0 or better Grade Point Average
- . Applicant must graduate from high school before Monday, June 26, 2023,
and planning to attend a college or university in the United States, before/by Fall of 2023.
- . Applicant must be registered at an accredited educational institution on a full time basis as defined by the institution.

Application Requirements

- . Make sure you completely fill out and sign your application.
Incomplete applications will result in applicant's ineligibility.
- . A sealed official academic transcript must be submitted with application.
- . Obtain two (2) letters of recommendations from any of the following: teacher, counselor, principal, pastor, employer, sponsor or someone that knows you well.
- . Verification of admittance from the institution the student will attend must be confirmed by the Scholarship Chair before award is issued.
- . Completed Application (Including letters of recommendations and transcripts) must be submitted/postmarked on or before, Friday, April 7, 2023.

The Illinois Student Assistance Commission (ISAC) is pleased to announce availability of the 2023-24 Nursing Education Scholarship Program (NESP) application. Links included in this message provide access to program information and the online application.

Program Highlights

- This program was designed to assist individuals who are pursuing a certificate in practical nursing, an associates degree in nursing, a hospital-based diploma in nursing or a bachelor's or graduate degree in nursing and who demonstrate the greatest financial need among qualified students.
- The scholarship pays for coursework within the nursing curriculum, but does not pay for pre-requisite coursework.
- The [number of years for which NESP funding may be received](#) is based on the certificate, diploma, or degree being pursued.
- Scholarship recipients must begin full- or part-time employment as a licensed practical or registered nurse in Illinois within six months of graduating, and remain employed for a period equivalent to the educational time supported by the scholarship.
 - If this commitment is not fulfilled, the scholarship converts to a loan, which must be repaid with interest.
- To be considered for funds during the 2023-24 academic year, the NESP Application/Promissory Note/Grant Agreement must be submitted to ISAC on or before **Sunday, April 30, 2023**.

Scholarship Guidelines

General Information

Scholarships are made possible by gifts from individuals, families, congregations, and other expressions of the Trinity African Methodist Episcopal Church. Scholarship funds are used as investments in applicants attending College.

By completing an application, you will be considered for the scholarship for which monies are available. Please submit only ONE application. The Scholarship Committee of Trinity African Methodist Episcopal Church determines if the applicant qualifies. The maximum award for any recipient is to be determined by the Scholarship Committee and the Stewardship and Finance Commission of Trinity African Methodist Episcopal Church. Only ONE (1) scholarship per applicant will be awarded per academic year.

All required documentation must be received in the Scholarship Committee's office before the deadline (application, references, transcripts, and school enrollment confirmation) by April 30th of the applicable year.

Eligibility

Applicants may apply for a scholarship only if they meet the eligibility requirement set for the particular scholarship. Additionally, scholarships are non-transferable and must be accepted as awarded. Applicants may apply for scholarships each academic year up to age 22. Trinity African Methodist Episcopal Church reserves the right to disqualify any applicant from the scholarship at its sole discretion at any time. Trinity African Methodist Episcopal Church also reserves the right to modify or terminate scholarships at any time for reasons in its sole discretion, with or without notice. To be eligible for scholarships the applicant must:

- Be a graduating High School student
- Be a member of the Trinity African Methodist Episcopal Church or be a resident in Waukegan, North Chicago, or Zion
- Letter of Acceptance to an Institution of Higher Education and proof of enrollment for upcoming semester
- Provide TWO (2) reference letters from the following (Religious Leader, Teacher/Instructor, or job)
